A. PRICE

The Contractor shall complete all work, including furnishing all labor, material, equipment and services required under this purchase order for the following firm fixed price and within the time specified. This price shall include all labor, materials, all insurances, overhead and profit.

VALUE ADDED TAX (VAT). The Government will not reimburse the Contractor for VAT under this contract. The Contractor shall not include a line for VAT on Invoices as the U.S. Embassy has a tax exemption certificate with the host government.

B. SCOPE OF WORK

The character and scope of the work are set forth in the contract. The Contractor shall furnish and install all materials required by this contract.

In case of differences between small and large-scale drawings, the latter will govern. Where a portion of the work is drawn in detail and the remainder of the work is indicated in outline, the parts drawn in detail shall apply also to all other portions of the work.

C. PACKAGING AND MARKING

Reserved.

D. INSPECTION AND ACCEPTANCE

The COR, or his/her authorized representatives, will inspect from time to time the services being performed and the supplies furnished to determine whether work is being performed in a satisfactory manner, and that all supplies are of acceptable quality and standards.

The Contractor shall be responsible for any countermeasures or corrective action, within the scope of this contract, which may be required by the Contracting Officer as a result of such inspection.

D.1 SUBSTANTIAL COMPLETION

(a) "*Substantial Completion*" means the stage in the progress of the work as determined and certified by the Contracting Officer in writing to the Contractor, on which the work (or a portion designated by the Government) is sufficiently complete and satisfactory. Substantial completion means that the property may be occupied or used for the purpose for which it is intended, and only minor items such as touch-up, adjustments, and minor replacements or installations remain to be completed or corrected which:

(1) do not interfere with the intended occupancy or utilization of the work, and
(2) can be completed or corrected within the time period required for final completion.

(b) The "date of substantial completion" means the date determined by the Contracting Officer or authorized Government representative as of which substantial completion of the work has been achieved.

Use and Possession upon Substantial Completion - The Government shall have the right to take possession of and use the work upon substantial completion. Upon notice by the Contractor that the work is substantially complete (a Request for Substantial Completion) and an inspection by the Contracting Officer or an authorized Government representative (including any required tests), the Contracting Officer shall furnish the Contractor a Certificate of Substantial Completion. The certificate will be accompanied by a Schedule of Defects listing items of work remaining to be performed, completed or corrected before final completion and acceptance. Failure of the Contracting Officer to list any item of work shall not relieve the Contractor of responsibility for complying with the terms of the contract. The Government's possession or use upon substantial completion shall not be deemed an acceptance of any work under the contract.

D.2 FINAL COMPLETION AND ACCEPTANCE

D.2.1 "Final completion and acceptance" means the stage in the progress of the work as determined by the Contracting Officer and confirmed in writing to the Contractor, at which all work required under the contract has been completed in a satisfactory manner, subject to the discovery of defects after final completion, and except for items specifically excluded in the notice of final acceptance.

D.2.2 The "*date of final completion and acceptance*" means the date determined by the Contracting Officer when final completion of the work has been achieved, as indicated by written notice to the Contractor.

D.2.3 FINAL INSPECTION AND TESTS. The Contractor shall give the Contracting Officer at least five (5) days advance written notice of the date when the work will be fully completed and ready for final inspection and tests. Final inspection and tests will be started not later than the date specified in the notice unless the Contracting Officer determines that the work is not ready for final inspection and so informs the Contractor.

D.2.4 FINAL ACCEPTANCE. If the Contracting Officer is satisfied that the work under the contract is complete (with the exception of continuing obligations), the Contracting Officer shall issue to the Contractor a notice of final acceptance and make final payment upon:

- Satisfactory completion of all required tests,
- A final inspection that all items by the Contracting Officer listed in the Schedule of Defects have been completed or corrected and that the work is finally complete (subject to the discovery of defects after final completion), and

- Submittal by the Contractor of all documents and other items required upon completion of the work, including a final request for payment (Request for Final Acceptance).

E. DELIVERIES OR PERFORMANCE

52.211-10 COMMENCEMENT, PROSECUTION, AND COMPLETION OF WORK
(APR 1984)

The Contractor shall be required to:

- (a) complete the entire work ready for use not later than **[14] calendar days after NTP commence start date.**

The time stated for completion shall include final cleanup of the premises.

52.211-12 LIQUIDATED DAMAGES - CONSTRUCTION (SEPT 2000)

(a) If the Contractor fails to complete the work within the time specified in the contract, or any extension, the Contractor shall pay liquidated damages to the Government in the amount of **[500 QR]** for each calendar day of delay until the work is completed or accepted.

(b) If the Government terminates the Contractor's right to proceed, liquidated damages will continue to accrue until the work is completed. These liquidated damages are in addition to excess costs of repurchase under the Default clause.

CONTRACTOR'S SUBMISSION OF CONSTRUCTION SCHEDULES

(a) The time for submission of the schedules referenced in FAR 52.236-15, "Schedules for Construction Contracts", paragraph (a), is hereby modified to reflect the due date for submission as **[7] calendar days** after receipt of an executed contract".

(b) These schedules shall include the time by which shop drawings, product data, samples and other submittals required by the contract will be submitted for approval.

(c) The Contractor shall revise such schedules (1) to account for the actual progress of the work, (2) to reflect approved adjustments in the performance schedule, and (3) as required by the Contracting Officer to achieve coordination with work by the Government and any separate contractors used by the Government. The Contractor shall submit a schedule, which sequences work so as to minimize disruption at the job site.

(d) All deliverables shall be in the English language and any system of dimensions (English or metric) shown shall be consistent with that used in the contract. No extension of time shall be allowed due to delay by the Government in approving such deliverables if the Contractor has failed to act promptly and responsively in submitting its deliverables. The Contractor shall identify each deliverable as required by the contract.

(e) Acceptance of Schedule: When the Government has accepted any time schedule; it shall be binding upon the Contractor. The completion date is fixed and may be extended only by a written contract modification signed by the Contracting Officer. Acceptance or approval of any schedule or revision thereof by the Government shall not:

- (1) Extend the completion date or obligate the Government to do so,
- (2) Constitute acceptance or approval of any delay, or
- (3) Excuse the Contractor from or relieve the Contractor of its obligation to maintain the progress of the work and achieve final completion by the established completion date.

NOTICE OF DELAY

If the Contractor receives a notice of any change in the work, or if any other conditions arise which are likely to cause or are actually causing delays which the Contractor believes may result in late completion of the project, the Contractor shall notify the Contracting Officer. The Contractor's notice shall state the effect, if any, of such change or other conditions upon the approved schedule, and shall state in what respects, if any, the relevant schedule or the completion date should be revised. The Contractor shall give such notice promptly, not more than ten (10) days after the first event giving rise to the delay or prospective delay. Only the Contracting Officer may make revisions to the approved time schedule.

NOTICE TO PROCEED

(a) After receiving and accepting any bonds or evidence of insurance, the Contracting Officer will provide the Contractor a Notice to Proceed. The Contractor must then prosecute the work, commencing and completing performance not later than the time period established in the contract.

(b) It is possible that the Contracting Officer may elect to issue the Notice to Proceed before receipt and acceptance of any bonds or evidence of insurance. Issuance of a Notice to Proceed by the Government before receipt of the required bonds or insurance certificates or policies shall not be a waiver of the requirement to furnish these documents.

WORKING HOURS

All work shall be performed during **07:30 to 16:00 Sunday through Thursday**. Other hours, if requested by the Contractor, may be approved by the Contracting Officer's Representative (COR). The Contractor shall give 24 hours in advance to COR who will consider any deviation from the hours identified above. Changes in work hours, initiated by the Contractor, will not be a cause for a price increase.

PRECONSTRUCTION CONFERENCE

A preconstruction conference will be held **(7) days** after contract award at [*U.S Embassy Doha, Qatar*] to discuss the schedule, submittals, notice to proceed, mobilization and other important issues that effect construction progress. See FAR 52.236-26, Preconstruction Conference.

F. ADMINISTRATIVE DATA

652.242-70 CONTRACTING OFFICER'S REPRESENTATIVE (COR) (AUG 1999)

(a) The Contracting Officer may designate in writing one or more Government employees, by name or position title, to take action for the Contracting Officer under this contract. Each designee shall be identified as a Contracting Officer's Representative (COR). Such designation(s) shall specify the scope and limitations of the authority so delegated; provided, that the designee shall not change the terms or conditions of the contract, unless the COR is a warranted Contracting Officer and this authority is delegated in the designation.

(b) The COR for this contract is **Facility Manager or his designate.**

Payment: The Contractor's attention is directed to Section H, 52.232-5, "Payments Under Fixed-Price Construction Contracts". The following elaborates on the information contained in that clause.

Requests for payment, may be made no more frequently than monthly. Payment requests shall cover the value of labor and materials completed and in place, including a prorated portion of overhead and profit.

After receipt of the Contractor's request for payment, and on the basis of an inspection of the work, the Contracting Officer shall make a determination as to the amount, which is then due. If the Contracting Officer does not approve payment of the full amount applied for, less the retainage allowed by in 52.232-5, the Contracting Officer shall advise the Contractor as to the reasons.

Under the authority of 52.232-27(a), the 14 day period identified in FAR 52.232-27(a)(1)(i)(A) is hereby changed to 30 days.

G.2.0 INSURANCE - The Contractor is required by FAR 52.228-5, "Insurance - Work on a Government Installation" to provide whatever insurance is legally necessary. The Contractor shall at its own expense provide and maintain during the entire performance period the following insurance amounts:

G.2.1 GENERAL LIABILITY (includes premises/operations, collapse hazard, products, completed operations, contractual, independent contractors, broad form property damage, personal injury) :

G.2.2 The foregoing types and amounts of insurance are the minimums required. The Contractor shall obtain any other types of insurance required by local law or that are ordinarily or customarily obtained in the location of the work. The limit of such insurance shall be as provided by law or sufficient to meet normal and customary claims.

G.2.3 The Contractor agrees that the Government shall not be responsible for personal injuries or for damages to any property of the Contractor, its officers, agents, servants, and employees, or any other person, arising from and incident to the Contractor's performance of this contract. The Contractor shall hold harmless and indemnify the Government from any and all claims arising therefrom, except in the instance of gross negligence on the part of the Government.

G.2.4 The Contractor shall obtain adequate insurance for damage to, or theft of, materials and equipment in insurance coverage for loose transit to the site or in storage on or off the site.

G.2.5 The general liability policy required of the Contractor shall name "the United States of America, acting by and through the Department of State", as an additional insured with respect to operations performed under this contract.

G.3.0 DOCUMENT DESCRIPTIONS

G.3.1 SUPPLEMENTAL DOCUMENTS: The Contracting Officer shall furnish from time to time such detailed drawings and other information as is considered necessary, in the opinion of the Contracting Officer, to interpret, clarify, supplement, or correct inconsistencies, errors or omissions in the Contract documents, or to describe minor changes in the work not involving an increase in the contract price or extension of the contract time. The Contractor shall comply with the requirements of the supplemental documents, and unless prompt objection is made by the Contractor within 20 days, their issuance shall not provide for any claim for an increase in the Contract price or an extension of contract time.

G.3.1.1. RECORD DOCUMENTS. The Contractor shall maintain at the project site:

- (1) a current marked set of Contract drawings and specifications indicating all interpretations and clarification, contract modifications, change orders, or any other departure from the contract requirements approved by the Contracting Officer; and,
- (2) a complete set of record shop drawings, product data, samples and other submittals as approved by the Contracting Officer.

G.3.1.2. "As-Built" Documents: After final completion of the work, but before final acceptance thereof, the Contractor shall provide:

- (1) a complete set of "as-built" drawings, based upon the record set of drawings, marked to show the details of construction as actually accomplished; and,
- (2) record shop drawings and other submittals, in the number and form as required by the specifications.

G.4.0 LAWS AND REGULATIONS - The Contractor shall, without additional expense to the Government, be responsible for complying with all laws, codes, ordinances, and regulations applicable to the performance of the work, including those of the host country, and with the lawful orders of any governmental authority having jurisdiction. Host country authorities may not enter the construction site without the permission of the Contracting Officer. Unless otherwise directed by the Contracting Officer, the Contractor shall comply with the more stringent of the requirements of such laws, regulations and orders and of the contract. In the event of a conflict between the contract and such laws, regulations and orders, the Contractor shall promptly advise the Contracting Officer of the conflict and of the Contractor's proposed course of action for resolution by the Contracting Officer.

G.4.1 The Contractor shall comply with all local labor laws, regulations, customs and practices pertaining to labor, safety, and similar matters, to the extent that such compliance is not inconsistent with the requirements of this contract.

G.4.2 The Contractor shall give written assurance to the Contracting Officer that all subcontractors and others performing work on or for the project have obtained all requisite licenses and permits.

G.4.3 The Contractor shall submit proper documentation and evidence satisfactory to the Contracting Officer of compliance with this clause.

G.5.0 CONSTRUCTION PERSONNEL - The Contractor shall maintain discipline at the site and at all times take all reasonable precautions to prevent any unlawful, riotous, or disorderly conduct by or among those employed at the site. The Contractor shall ensure the preservation of peace and protection of persons and property in the neighborhood of the project against such action. The Contracting Officer may require, in writing that the Contractor remove from the work any employee that the Contracting Officer deems incompetent, careless, insubordinate or otherwise objectionable, or whose continued employment on the project is deemed by the Contracting Officer to be contrary to the Government's interests.

G.5.1 If the Contractor has knowledge that any actual or potential labor dispute is delaying or threatens to delay the timely performance of this contract, the Contractor shall immediately give notice, including all relevant information, to the Contracting Officer.

G.5.2 After award, the Contractor has seven calendar days to submit to the Contracting Officer a list of workers and supervisors assigned to this project for the Government to conduct all necessary security checks. It is anticipated that security checks will take [10 days] to perform. For each individual the list shall include:

1. QID
2. Passport Copy
3. Place and Date of Birth
4. Current Address
5. Make model, color, and registration plate number of the Vehicle, which may come inside the Embassy compound
6. Photocopies of passport and Qatar work permit visa of the driver who will drive the vehicle.

Note: If any person, who does not get a security clearance from the Regional Security Office, will not be allowed inside the Embassy compound.

Failure to provide any of the above information may be considered grounds for rejection and/or resubmittal of the application. Once the Government has completed the security screening and approved the applicants a badge will be provided to the individual for access to the site. This badge may be revoked at any time due to the falsification of data, or misconduct on

site.

G.5.3 The Contractor shall provide an English speaking supervisor on site at all times. This position is considered as key personnel under this purchase order.

G.6.0 Materials and Equipment - All materials and equipment incorporated into the work shall be new and for the purpose intended, unless otherwise specified. All workmanship shall be of good quality and performed in a skillful manner that will withstand inspection by the Contracting Officer.

G.7.0 SPECIAL WARRANTIES

G.7.1 Any special warranties that may be required under the contract shall be subject to the stipulations set forth in 52.246-21, "Warranty of Construction", as long as they are not in conflict.

G.7.2 The Contractor shall obtain and furnish to the Government all information required to make any subcontractor's, manufacturer's, or supplier's guarantee or warranty legally binding and effective. The Contractor shall submit both the information and the guarantee or warranty to the Government in sufficient time to permit the Government to meet any time limit specified in the guarantee or warranty, but not later than completion and acceptance of all work under this contract.

G.8.0 EQUITABLE ADJUSTMENTS

Any circumstance for which the contract provides an equitable adjustment that causes a change within the meaning of paragraph (a) of the "Changes" clause shall be treated as a change under that clause; provided, that the Contractor gives the Contracting Officer prompt written notice (within 20 days) stating:

- (a) the date, circumstances, and applicable contract clause authorizing an equitable adjustment and
- (b) that the Contractor regards the event as a changed condition for which an equitable adjustment is allowed under the contract

The Contractor shall provide written notice of a differing site condition within 10 calendar days of occurrence following FAR 52.236-2, Differing Site Conditions.

G.9.0 ZONING APPROVALS AND PERMITS

The Government shall be responsible for:

- obtaining proper zoning or other land use control approval for the project
- obtaining the approval of the Contracting Drawings and Specifications
- paying fees due for the foregoing; and,
- for obtaining and paying for the initial building permits.

2.0 OBJECTIVES

2.1 The purpose of this scope of work is to make an office with dry walls and glass, fabrication and installation of new workstations and cabinets, fabricate and installation of fabric partition walls and electrical wiring to those workstations in the Foreign Commercial Section at the basement of the Chancery Building. All work shall be done in **accordance with this SOW and attached drawing.**

2.2 The contractor shall supply all materials and laborers for this project.

3.0 GENERAL REQUIREMENTS

3.1 The Contractor shall provide all services necessary to meet objectives shown in 2.0 above.

3.2 The Contractor shall visit the site and asses extend of work needed to repair/restore the area before submitting an estimate. The date of the site visit will be determined by the General Services Office of the Embassy.

3.3 The proposal shall include line items for materials, tools, expendable tools and supplies (cloths, rags, brushes, towels, etc.), site deliveries, staging, demobilization, demolition, including selective demolition, protection of site and surrounding work areas (health and safety/barriers, dust and debris controls, etc.), installation labor, trash and refuse removal from site and local disposal, all overhead and general and administration services and fees and contractor profit/fee.

- 3.4 The contractor's labor and material price quotes shall be based upon an agreed to quantity of corrugated sheet to be repaired under the contract. The agreed to quantity shall be established during the contractor's pre-bid site visit and inspection. Any changes to quantity and resultant costs shall be negotiated by the contracting officer.
- 3.5 The contractor's proposal shall also include a schedule that includes milestones for work start, material deliveries, and work completion. The schedule shall include time durations for each work activity.

3.6 WORK, LICENSES, PERMITS AND INSPECTIONS

The contractor shall perform all work in accordance with any plans, specifications, and performance standards and in accordance with local or Internal Building Code (International Code Council). The contractor shall be responsible to obtain any local permits or building permits in accordance with local law or custom, prior to beginning work. The contractor shall furnish all trade labor that possesses tradesman licensing, as required, per local law/requirements. The contractor's superintendent shall inform the Post Facility Manager within two (2) business days when US Government site and work inspections are required.

3.7 LIABILITY INSURANCE

- 3.7.1 The contractor shall provide and maintain required general liability insurance against claims made for damages for personal injury or property damage by reason of anything done or not done by the contractor, its employees or agents, in connection with the performance of this contract. The contractor shall furnish these insurance documents to the contracting officer at the same time the work proposal is tendered.

3.8 HEALTH & SAFETY PLAN

- 3.8.1 The contractor shall be responsible to execute all work in accordance Occupational Safety and Health requirements, OBO Safety Manual (Army Corps of Engineers EM-385), Post specific safety and health procedures and policies. The contractor shall be responsible to erect and remove all dust and debris controls in order to execute the drywall repairs and restorations. All health and safety control measures, barrier, dust extractions, fans, general clean-up of site, etc. shall also be performed by the contractor during the execution of this contract.
- 3.8.2 Safety Requirements for this project is the use of PPE by contractor's workers.
- 3.8.3 Contractor shall ensure users of Personal Protective and Safety Equipment are trained to know the following:

2. The awarding of this Contract shall be based on the assurance that adequate, qualified manpower will be provided to carry out this scope of work, and work will be commenced and completed as per the Project Schedule, as revised from time to time by the contractor's Construction Manager and as agreed to by the Post/US Government contracting officer.

3. The contractor shall provide additional labor, including safety personnel, for overtime and weekend work as required from time to time to comply with Project Schedule at no additional cost to the US Government.
 4. The contractor shall cooperate with other trades that may be performing other work to ensure a smooth and safe flow of work.
 5. The contractor shall comply with all requirements for safety procedures, reports, and meetings in accordance with applicable regulations, laws, and safety programs.
 6. As required, the contractor shall be responsible to furnish all tools and equipment to perform work under this contract. The US Government will not furnish any property, tools or equipment for this project. The contractor shall ensure that all necessary tools and equipment are available and fit for service to avoid any schedule delays. Contractor delays relating to tool and equipment availability is not an excusable or compensable reason for delay under this contract.
 7. The contractor agrees that the US Government is not responsible for fire, theft, loss and/or vandalism of any of the contractor's property, including tools, equipment, materials, supplies and/or work in progress.
 8. The contractor shall adhere to all Post security policies and requirements to include those for site access, vehicle and equipment access and personnel background checks. These specific requirements will be furnished to the contractor at the time of contract award.
- 3.8.4 ACCEPTANCE OF WORK: The Contractor shall provide certification that work was approved and accepted by the Contracting Officers Representative, COR, at post. The Contractor shall fill out the work order completion form (attachment C) showing work was completed as required in section 3.0 and 4.0 of this SOW and provide the form to the Facility Manager or his official representative. Attached is the sketch showing where the contractor shall make an office room using dry walls and tempered glass; fabricate and install two new workstations; rearrange other workstations as shown in the drawing; fabricate and install fabric partition walls. The contractor may find dimensions from sketches; however, these dimensions are approximate. The contractor shall verify it during his site visit.

The contractor shall make every effort to protect the adjacent property during execution of the project. Its contractor's responsibility for restoration of damages incurred during implementation of the plan. The contractor shall follow Qatar Civil Work Standards and Specifications of 2018 or more throughout the entire project. The work shall be governed by the U.S. Embassy, Doha. International codes, which includes the National Fire Preventive Association (NFPA), International Building Code, International Mechanical Code, National Electric Code (NEC), and International ASHRAE (American Society of Heat Refrigeration and Energy) also are applicable. The contractor is responsible for compliance with all Building Codes; Work not in compliance with the Codes shall be deemed to be unacceptable.

All material supplied by the contractor must be UL (Under laboratories of the U.S.A.) of CE (European Union countries) approved. COR or his representative has full right to cancel any material if it doesn't meet the standard.

Any tools and machines that the contractor is bringing at the site must comply with UL (Under laboratories of the U.S.A.) of CE (European Union countries); otherwise it won't be allowed to use at the site.

The measurement mentioned the drawing are approximate. The contractor shall verify this measurement during site visit. The contractor shall not claim any additional amount after the project is over.

The contractor shall make every effort to protect the adjacent property. Its contractor's responsibility for restoration of damages incurred during implementation of the plan.

The contractor must ensure a one-year warranty for this project. The completion of the project date would only be ensured by the contracting officer's representative (COR).

a. **MAKING OF AN OFFICE:**

- i. The contractor shall confirm all these dimensions during site visit. The contractor shall and install water and moisture resistance type dry walls only, please refer to Appendix B. The thickness of the dry walls shall not be less than 10 mm.
- ii. All dry walls shall be installed as per manufacturer's recommendations. Work shall include, but shall not necessarily be limited to, the following:
The complete drywall finish to a level four standard, ready for interior finishing and paint as per the US Gypsum Company, Drywall Finishing Standards. The contractor is provided a copy of this standard as appendix A to this scope of work.
- iii. The contractor shall paint all wall surfaces quantities to a level 5, per the furnished US Gypsum standard. Final paint color, textures, hues, etc., shall match surrounding areas. Where this is not practical, the contractor shall finish, patch/repair, prime and paint the entire drywall surface area to a level 5 standard.
- iv. The contractor shall make all framework with white wood available locally. Fabrication of the white woods shall be done in contractor's workshop. Those shall be brought at the Embassy site for installation only.
- v. Thickness of the dry partition walls shall be 100 mm. wide and from the floor to the ceiling. Approximate height of the wall to the ceilings has been marked in the drawing. The contractor shall verify these heights during the site visit.
- vi. The contractor shall fabricate and install whitewood base board with varnish. The baseboards shall be made of 10 mm. thick white wood, locally available. Height of the baseboard shall be 100 mm. A sample of the baseboard shall be shown to the contractor during site visit.
- vii. The contractor shall supply and install 10 mm. thick tempered glass as shown in the drawing. The contractor shall produce certificate of the glass before installation.
- viii. The contractor shall supply and install a glass sliding door as shown in the drawing. The glass sliding door shall be operated by a motion sensor. Sliding door shall be made of 10 mm. thick tempered glass. The motion sensor shall be UL (Under laboratories of

the U. S. A.) of CE (Community of European Union). The contractor shall make sure to meet the dimensions of the door as mentioned in the sketch.

- ix. The contractor shall relocate three electrical power outlets as shown in the sketch on the walls as shown in the drawing. The contractor shall supply and install additional three 13 A, 3 pin, double gang, 230 V, 1 phase power outlets for new printer and refrigerator as shown in the drawing. The contractor shall do all necessary electrical wiring through P.V.C. casing. All electrical wiring shall be concealed type through the partition walls.

b. FABRICATION AND INSTALLATION OF PARTITION WALLS:

- i. The contractor shall fabricate and install partition walls as per dimensions as shown in the drawing. A sample of the fabric petition walls shall be shown during the site visit. The contractor shall maintain the same quality and dimension as mentioned in the sketch. The height of the partition wall shall be fabricated as per drawing. Please refer to “C – C” and “D- D” of the drawing reference. Please refer to elevation plans of the partition walls; the contractor may find the height and width. Please note thickness of the walls shall be 60 mm.
- ii. The contractor shall fabricate all these workstations and partition walls and bring at the site for installation.
- iii. The Embassy will choose the color and quality of the fabric. The contractor shall bring fabric sample catalogue at the Embassy.

c. FABRICATION AND INSTALLATION FURNITURE:

- i. The contractor shall fabricate furniture number 1 to 4. Contractor shall determine height of the new furniture during the size visit. Other dimensions of the new furniture shall be followed otherwise.

The contractor shall make this furniture with 18 mm. thick MDF (Medium Density fiberboard) plywood. Surface of this desk shall finish with HPL (High Pressure Laminate) sheets. The contractor shall provide few samples of HPL sheets to the COR for approval prior to installation. Dimension and height of the desk are mentioned in the attached drawing.

- ii. Surface of the file cabinet shall be finished with HPL sheets.
- iii. During site visit the contractor shall find the design of the new workstation.
- iv. The contractor shall fabricate new workstation in his workshop and bring at the site to install.

- v. The contractor shall bring furniture catalogues during the site visit. This might help the Embassy personnel to choose any design.

d. REINSTALLATION OF EXISTING WORKSTATION:

The contractor shall relocate and reinstall one existing workstation and a cabinet in the proposed new office as shown in the drawing.

e. ELECTRICAL WORK:

The contractor shall strictly adhere to the National Electrical Code (NEC) 2018 of the U.S.A. during entire electrical installation of this project.
